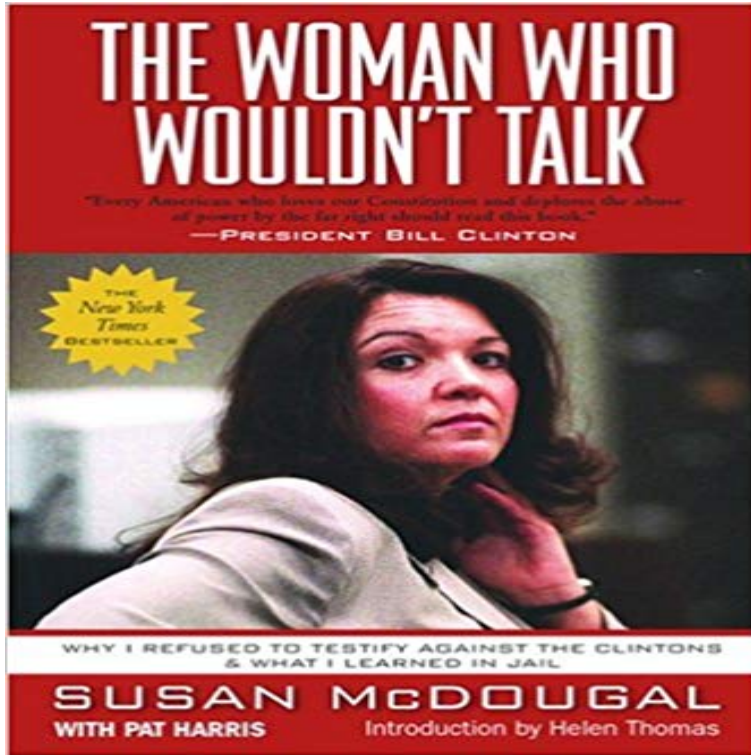


The Woman Who Wouldnt Talk: Why I Refused to Testify Against the Clintons and What I Learned in Jail



How a small-town Arkansas girl became a nationally known felon is one of the more troubling legacies of the Clinton era. After all, Susan McDougal grew up making patriotic speeches at the local American Legion. We are diligent to not purchase, offer or grow GMO seeds or food.

Our mix of garden starts includes many different varieties of tomatoes, cucumbers, peppers, ground cherries, pumpkins, melons, flowers and other great things for your garden!
